## Houston Bar Foundation Marks 25<sup>th</sup> Anniversary at Annual Luncheon Baker to Take Office as HBF Chair, Kline Keynote Speaker

The Houston Bar Foundation will hold its 25<sup>th</sup> Anniversary Annual Meeting and Luncheon on Thursday, January 24, 2008, beginning at 11:30 a.m. at The Four Seasons Hotel Ballroom. Debra Tsuchiyama Baker of Connelly • Baker • Wotring • Jackson LLP will become the 2008 chair of the Foundation. The Foundation also will present its 2008 awards for volunteer service.

The keynote speaker will be Mark W. Kline,

M.D., Professor of Pediatrics-Retrovirology at Baylor College of Medicine and Texas Children's Hospital.

Dr. Mark Kline has been treating children with HIV/AIDS since the epidemic first surfaced among these youngest of patients in the late 1980s. He has been instrumental in investigations of clinical therapies that have radically changed the outlook for children with HIV/AIDS from one of little hope to successful treatments that are allowing them to enter adulthood with a quality of life never imagined only 15 years ago.

As president of the BCM International Pediatric AIDS Initiative at Texas Children's Hospital, Dr. Kline oversees an ambitious program that encompasses HIV/AIDS care and treatment and health professional education and training programs in 20 African countries, Mexico, Romania, Ukraine and China. The program provides treatment to more children than any other organization worldwide.
